

Hello Mayor Diaz and Council Member Wan,

The CBCA Board has met to consider your committee's response to our latest offer regarding our entering into a new MUA together.

Let me recap what we propose-

In exchange for a waiver of the Special Events Fee, the CBCA would agree to the following:


- 4% of gross operating revenue contributed to the City from our festivals taking place on City-owned property only, with a maximum cap of \$28,000.
- We suggest that Bret weighs in on how we may contribute this revenue directly to a list of specific capital improvement projects, as our bylaws do not permit us to donate to a general fund. Also, we want to ensure that the CBCA is recognized by the City, as others have been, for our contributions.
- We are not obligated to begin contributions from our festivals until 2025, beyond actual cost recovery, and do not wish to reduce our charitable contributions in 2024. Therefore, we propose the agreed payment date be following Oktoberfest 2025 but would offer to enter into a signed agreement in 2024 stating as such and would further offer to make a 2024 \$10K contribution to a specific, mutually agreed upon, capital improvement project.
- Further, we offer to save the City from having to do a costly RFP for an outside entity to fund/manage/produce the City's 4th of July Parade. The CBCA volunteers have worked with the City Staff for many years on the parade and have the expertise to produce the event, as well as the ability to fund it. The CBCA would take on the

responsibility of ensuring that the parade continues as usual and without interruption.

· We would also continue as a banner sponsor for the Concerts in the Grove and will continue to partner with the City on Holidays in the Grove/Tree Lighting and holiday decorations and would assist financially with the upcoming Clayton 60th Anniversary celebration as well.

The CBCA believes this to be our best and final offer and we hope that you will take this back to the full Council for consideration so that we may rekindle our partnership with a fresh start in the New Year.
