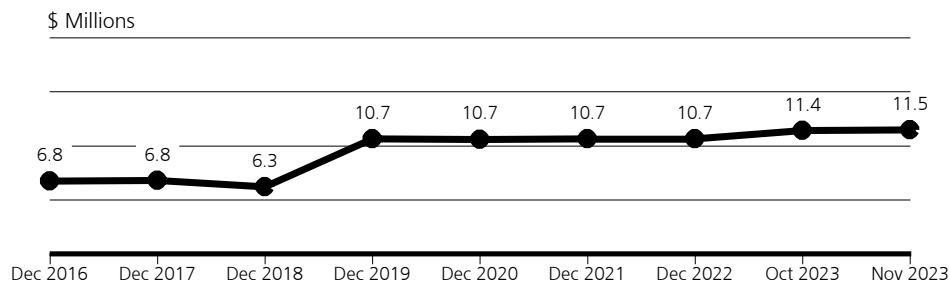

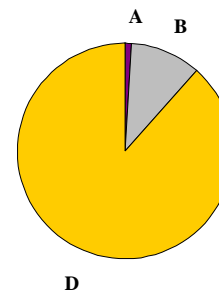

Money market funds

Government and retail money market funds will continue to transact at a stable \$1.00 net asset value.
